- Conducting external supplier/subcontractor audits;
- Conducting visual and physical inspection of aircraft parts and components;
- Supporting root cause/corrective actions and process improvements within the business;
- Identifying risks and planning mitigating actions to ensure compliance and improved quality;
- Providing technical assistance and quality training support to operations;
- Developing standard work process where required to continually improve the definition of QC inspection standards;
- Completing Non-Conformance Report dispositions when required;
- Maintaining the technical configuration of 3PA quality documentation;
- Working within the provisions and guidelines of the 3PA QA system;
- Safety – Responsible for personal safety, safe working practices etc. Understand and follow the 3PA OH&S procedures; and
- Performing other related duties as required and assigned.

- Conduct regulatory internal audits to support TCCA and AS9100 certification requirements;
- Assist with the control and disposition of ERP system inventory through, condition, location and final status;
- Coaching and training staff;
- Measurement and verification of product; and
- Travel to various company sites and suppliers will be required.
